She was a Staff Hematopathologist at the Wilkes-Barre General Hospital before serving as Staff Pathologist, Hematopathologist, Cytopathologist, and Director of the Flow Cytometry and Molecular Laboratory at Southern Pathology Services in Ponce, Puerto Rico. She was also Staff Hematopathologist and Cytopathologist, as well as Assistant Professor, at the University of Tennessee Health Science Center. She currently serves as a Staff Pathologist with Consultants in Laboratory Medicine.
